Ordinance No. O-2007-4

***An Ordinance Amending the Wage and Benefit Policy for Haskins Village and  
Declaring an Emergency***

**WHEREAS**, the Village Council of Haskins, Ohio has previously adopted the Wages and Benefits Policy as per Ordinance O-2005-8 and it is now necessary to create the position of Streets & Utilities Superintendent and Electric Linesman;

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Haskins, Wood County, Ohio, that:

**SECTION 1:** Ordinance Number O-2005-8 is hereby amended to include the addition of Section 20:21 to read as follows:

*20:21 STREETS/UTILITIES SUPERINTENDENT AND ELECTRIC LINESMAN  
The Streets/Utilities Superintendent and Electric Linesman is appointed by the Village Administrator with the approval of the Mayor and shall serve at the direction of the Village Administrator. This position shall be classified as a Part-Time position. Eighty percent (80%) of the compensation for this position shall be derived from the Electric Fund; ten-percent (10%) from the Sewer Fund and ten-percent (10%) from the Street Fund.*

**SECTION 2:** The position of Streets/Utilities Superintendent and Electric Linesman shall be classified as a salary (Part-Time) position with the rate of pay affixed in the Compensation Schedule at \$1,169.50 for a 50-hour pay period.

**SECTION 3:** This Ordinance is hereby declared to be an emergency necessary for the immediate preservation of the public health, safety and welfare of the Village and its residents as it is required that a sufficient number of municipal employees are available to effectively manage and maintain services provided by the Village of Haskins.

**SECTION 4:** That it is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including **Section 121.22** of the **Ohio Revised Code**.


